WEDNESDAY – 28 APRIL 2021

The University Council Chairman opened the meeting, greeted all the Participants and noted the excused absence of Katarzyna Zajdel-Kurowska.

The Chairman proposed the following agenda:

Re: 5. Resolution on granting permission to establish a paid transmission easement on the real estate located at ul. Hoża 74 in Warsaw for the benefit of Veolia Energia Warszawa S.A. with its registered seat in Warsaw

The University Council decided to request the Real Estate Registry Office to provide supplementary information on the purpose and consequences of establishing an easement covered by the application.

Re: 6. Resolution on the University Council approving the performance by the University of Warsaw of a legal act consisting in the disposition of fixed assets, as defined in the accounting regulations, and performance by a public university of a legal act consisting in transferring such assets for the use of another entity, for a period longer than 180 days in a calendar year.

Dr Artur Chełstowski (Vice-Chancellor for Economic Affairs) joined the discussion and resolved the doubts of the University Council members concerning the resolution as they were being raised. The University Council decided to request additional consultation from the Legal Office.

The University Council decided to change the order of topics to be discussed by proceeding to item 8 of the agenda.

Re: 8. Meeting with the Rector's Team – discussion on the most important matters for the University

His Magnificence, Rector Professor Alojzy Z. Nowak, PhD introduced the members of the Rector's Team.

His Magnificence the Rector presented the financial standing of the University, indicating that it is very good. He also raised the issue of the Centre of New Technologies, explaining that a peaceful solution to the conflict was reached.

Then, His Magnificence the Rector discussed the matter of the assessment of the University in terms of research conducted. The goal is to be awarded the highest grade (A+) in this category. He indicated that the number of research programs at the University increased and new programs provided financial benefits. He also mentioned cooperation with the financial sector, which is becoming more intensive.

Due to the current circumstances (COVID-19 pandemic), topics discussed also included preparations for the new academic year in the *online* and *face-to-face* variants, as well as student vaccinations.

In terms of new investments and development, His Magnificence the Rector informed that the University is implementing the Green University idea (environmental protection, smart buildings, alternative energy sources). He also mentioned that students will be involved in designing the new student residence hall.

His Magnificence the Rector also highlighted ideological problems, as well as issues of sexual offences and illicit drug use.

Finally, he expressed his satisfaction with working with the Rector's Team and other University employees.

The University Council returned to item 7 of the Agenda.

The University Council decided to request that Human Resources Office to provide supplementary information that would confirm that an update to the Rector's performance allowance is justified.
