His Magnificence the Rector welcomed all the participants to the meeting and presented the most important current issues concerning the University, including:

- current status of the process of establishing a faculty of medicine;
- results of the evaluation;
- unveiling of a plaque on the so-called "ghetto bench";
- fundraising for the Smart Green University project;
- raising funds for the maintenance of research potential;
- activating the young researcher and graduate community at the University;

The members of the University Council asked questions during the discussion of this agenda item, and the Chairman of the University Council managed the discussion of individual issues.



Re: 7. Draft Strategy of the University of Warsaw - expression of opinion

The motion in question was presented by Prof. Ewa Krogulec (the UW Vice-Rector for Development), noting that we are the largest academic community in the country, one of the largest and most important academic institutions in our part of Europe, an institution with enormous potential and great aspirations, thoroughly modern, with a developed culture of innovative research and education, creating and disseminating cutting-edge scientific knowledge, shaping trends and responsible attitudes, at the same time seeking to respond to current as well as future challenges. The new UW Strategy will become a tool that will contribute to improving the conditions for creating outstanding and ground-breaking research and strengthening teaching excellence. We want to build the University as an open, pioneering but responsible academic community, whose foundations are independence, commitment, boldness of thought, tolerance, as well as respect and dialogue.

Prof. Ewa Krogulec discussed in detail the provisions of the strategy and the process of its creation and public consultation.

The members of the University Council made the following comments on the draft Strategy:

- the lack of vision for the University of Warsaw in the future;
- the lack of description of how the Rector's Team will guide the organisation through the change;
- the lack of measurable indicators of strategy implementation;
- no explanation how it will be implemented and verified;
- no references from external experts;
- the strategy document is too broad, contains repetitions, and does not define concepts, making them vague;
- the executive summary should be included at the beginning of the document.

Prof. Ewa Krogulec (UW Vice-Rector for Development) responded in detail to the concerns raised by members of the University Council, paying particular attention to the fact of the heterogeneity of the units, which translates into both the structure of the strategy document and the detail this necessitates. In doing so, she emphasised that the comments made so far by members of the University Council had been taken into account and included in the content of the Strategy. At the same time, the Vice-Rector explained that the measures for the implementation of the Strategy would be included in the implementation plan, the implementation of which will be presented to the University Senate and at the same time enable a participatory approach to the implementation of the Strategy.

His Magnificence the Rector stated that the Rector's Team would review the comments made by members of the University Council and will submit a revised Strategy document at one of forthcoming meetings.



Re: 8.The information by the Vice-Chancellor for Economic Affairs on the implementation of the financial plan and on the current situation of the organizational units;
